Your Military at Work

The Portland Air National Guard Base is located on the south side of the Portland International Airport. The base was built by the Works Projects Administration (WPA) in 1936 and as an active-duty base was used for training and submarine patrol to air defense from World War II through 1965. Today, the property is managed by the Oregon Air National Guard's 142nd Wing but is also home to the Air Force Reserve 304th Rescue Squadron.

The 142nd Wing defends our homeland with F-15 Eagle fighter jets, guarding the Pacific Northwest skies from northern California to the Canadian border through their Aerospace Control Alert mission as part of Air Combat Command and the North American Aerospace Defense Command (NORAD).



In addition to providing Aerospace Control Alert for the Pacific Northwestern skies, the 142nd Wing provides Conventional and Special Forces in support of National and State Authorities. As Portland's hometown Air Force, we are here and ready to serve upon a moment's notice!

Military Personnel

Military Personnel Appropriation funding pays for military training, uniforms, food services, military travel, and Permanent Change of Station (PCS) expenses.

Operations and Maintenance (O&M)

Operations and Maintenance funding pays for the Flying Program, Security, Environmental, Fire protection costs, transportation costs, military medical clinic costs, vehicle costs, travel costs, and other costs associated with operating and maintaining the base. Expenditures do not include payroll costs for the programs.

Indirect Jobs Created

Indirect jobs reflects how money spent by base organizations and individuals ripple through the local economy, increasing the income of local businesses, which in turn allows them to hire new employees and do more spending of their own at their suppliers and other businesses. We measure the additional economic impact by estimating the number of indirect jobs created as a result of local base spending, and multiplying that by the estimated average salary in the Portland/Vancouver area. The estimated average salary in the Portland/Vancouver area is obtained from the Bureau of Labor Statistics. Indirect job multiplier is based on the size of the employment base for each region surrounding an installation and the general mission of the base.
